## Re: Freedom of Information Request

Dear Sir or Madame:

On behalf of Dr. Roger C.S. Lin, 2nd Floor, Number 212 Qing Nian 2nd Street, Ling Ya District, Gaoxiong City, Taiwan (the "Requestor"), and pursuant to the Freedom of Information Act ("FOIA"), 5 U.S.C. Section 552, and 22 C.F.R. Part 171, I am pleased to make this FOIA request.

Attached hereto as Schedule A are the documents requested from the Department of State ("DOS"). In order to aid the DOS in understanding and complying with this FOIA request, certain Capitalized words used in Schedule A are defined in Schedule B.

Dr. Lin asks for a fee waiver for this FOIA request. The information requested in this FOIA request is in the public interest and is not in the commercial interest of Dr. Lin. As made clear by the documents requested, such documents concern the operations and activities of the DOS. Dr. Lin has attempted to obtain the requested documents from all available sources available to him, both within and without Taiwan. Dr. Lin does not believe that the information requested is available in the public domain, and will not use the information for commercial purposes.

Dr. Roger C. S. Lin was born in Taiwan in 1950. He has a Ph. D. in international law from Meijo University, Nagoya, Japan. He is Chairman of the Taiwan Civil Democratic Party, spokesperson for the Taiwan Nation Party, and has been researching the international legal status of Taiwan for many years, in order that the civil rights of the Taiwanese people may be better protected in the world community. Dr. Lin's research covers all aspects of U.S. constitutional law and international law, including the laws of war recognized by the United States. Notably, on October 25, 2004, (former) Secretary of State Powell said: "Taiwan is not independent, it does not enjoy sovereignty as a nation." Again, on August 30, 2007, Mr. Dennis Wilder, National Security Council Senior Director for Asian Affairs, said: "Taiwan, or the Republic of China, is not at this point a state in the international community. The position of the United States government is that the ROC -- Republic of China -- is an issue undecided, and it has been left undecided, as you know, for many, many years." Yet, despite these announcements by

important U.S. Executive Branch officials, Dr. Lin is extremely troubled by the fact that the ROC continues to exercise full administrative authority over Taiwan and the Taiwanese people. This administrative authority includes the issuance of identification documents (including passports and ID cards) to native Taiwanese people that identify these people as "ROC citizens." Dr. Lin believes that such a citizenship classification is incorrect under international law and U.S. constitutional law, and hence is desirous of uncovering all relevant U.S. government documentation references pertaining to this subject. The documentation and information requested in this FOIA request will be used in all relevant academic, political, and other related venues where the topics of the civil rights of the Taiwanese people are being discussed—and NOT for commercial purposes.

In the unlikely event that a fee waiver cannot be to granted, Dr. Lin provides his assurance that fees up to a limit of US\$2,500.00 will paid to DOS for this FOIA request.

This FOIA request should not be considered or interpreted as a Privacy Act Request.

### **DOCUMENT REQUESTS**

#### **SCHEDULE B**

## **DEFINITIONS**

- 1. The "Allied Powers" means, according to Article 23(a) of the San Francisco Peace Treaty (defined herein), "Australia, Canada, Ceylon, France, Indonesia, the Kingdom of the Netherlands, New Zealand, Pakistan, the Republic of the Philippines, the United Kingdom of Great Britain and Northern Ireland, and the United States of America."
- 2. "AIT" means the American Institute in Taiwan, an entity formed pursuant to the TRA (as defined herein) and performing functions typically performed by the United States embassies and consulates abroad (such as processing passport and visa applications).
- 3. "General Order No. 1" means the General Order No. 1 issued by the Supreme Commander for the Allied Powers General Douglas MacArthur on Sept. 2, 1945, and published in J.C.S. 1467/2.
  - 4. "MOFA" means ROC's Ministry of Foreign Affairs.
  - 5. "Passport Application" means Form DS-11 Application for a U.S. Passport.
  - 6. "PRC" means People's Republic of China.
  - 7. "ROC" means the Republic of China.
- 8. "SFPT" or the "San Francisco Peace Treaty" means the Treaty of Peace with Japan, signed in San Francisco on September 8, 1951, by the Allied Powers and Japan, and entered into force on April 28, 1952. *See* 136 U.N.T.S. 46.

- 9. "Taiwan" means the islands of Taiwan (formerly called "Formosa") and the Pescadores.
- 10. "Taiwanese People" means natural persons who meet the following criteria: (1) being born of a mother and/or father who, as of October 25, 1945, was/were considered native to the areas of Formosa and the Pescadores, including their descendants up to the present, and (2) currently having Household Registration in the areas of Formosa and the Pescadores. "Taiwanese People" does <u>not</u> include such persons described in this paragraph 10 who have become U.S. citizens.
- 11. "TECO" means Taipei Economic and Cultural Office located in Atlanta, Boston, Chicago, Hagatna (Guam), Honolulu, Houston, Kansas City, Los Angeles, Coral Gables, New York, San Francisco, and Seattle.
- 12. "TECRO" means the Taipei Economic and Cultural Representative Office located in Washington, D.C.
  - 13. "TRA" means the Taiwan Relations Act, 22 U.S.C. §§ 3301-3316 (2007).
  - 14. "USMG" means United States Military Government.
